- AND WHEREAS, the ERC in its 274th meeting held on 15th 16th July, 2019 considered the matter along with the reply dated 22.08.2016 received on 29.08.2016 submitted by the institution in compliance to revised recognition order and as per decision of the ERC, Show Cause Notice was issued under section 17(1) of the NCTE Act, 1993 on 22.08.2019 to the institution.
- AND WHEREAS, the institution has submitted reply dt.03.08.2019 and dt.03.12.2019 received in this office on 13.08.2019 and 16.12.2019 respectively in response to Show Cause Notice. The ERC in its 278th meeting held on 16th - 18th January, 2020 considered the matter along with the reply and as per decision of the ERC, Final Show Cause Notice was issued under section 17(1) of the NCTE, Act, 1993 to the institution vide letter No.62163 dt.28.01.2020 on the following grounds:
 - i. Teaching faculty mentioned at Sl. No.13, 14 do not possess NET/ Ph.D. qualification as per amendment Gazette Notification dated 09.06.2017.

ii. Original FDRs of Rs.5 lakh and Rs.7 lakh to be submitted.

- iii. Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
- iv. Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- AND WHEREAS, the institution has submitted reply dt.01.02.2020 received on 07.02.2020. The ERC in its 280th meeting held on 29th February & 01st March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-

i. 2 Pedagogy faculties appointment is under process, which is not permissible as per NCTE Regulation, 2014.

ii. Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
